 gated therefor. I understand and agree that any injury received or disease contracted by me while a member of the  
 Civilian Conservation Corps cannot be made the basis of any claim against the Government, except such as I may be entitled  
 to under the act of February 15, 1924 (45 Stat. 361; U. S. C. 5: 796), and that I shall not be entitled to any allowances upon release  
 from camp, except transportation in kind to the place at which I was accepted for enrollment. I understand further that any articles  
 issued to me by the United States Government for use while a member of the Civilian Conservation Corps are, and remain, property  
 of the United States Government and that without destruction, loss, sale, or disposal of such property renders me financially responsi-  
 ble for the cost thereof and liable to trial in the civil courts. I understand further that any infraction of the rules or regulations of  
 the Civilian Conservation Corps renders me liable to expulsion therefrom. So help me God.
