Note D.—In making entries in columns 10, 11, 12, 13 or 14, an abbreviation such as "La" will be used, unless it is the name of a foreign person, in which case it will be the name of the country, with the letter "C" in it as in the following table.
 Note E.—Question No. 14 will only be asked in cases where an "A" or "C" is entered in column 10 or in question 11.
 Note F.—Question No. 18 will only be asked in cases where a child's occupation has been reported in column 12.
 Note G.—In column 19 an abbreviation in the name of the month may be used, as Jan., Apr., Dec.
