KILLED BY STREET CAR.

Daniel Brady Meets Death While Crossing Track.

Daniel Brady of 918 Louisa street was killed early this morning by being run down by car 048 of the Dauphine street line.

Brady was crossing Dauphine street at the intersection of Montegut street when he was struck by the car. He was picked up unconscious and hurried to the Charity Hospital, dying shortly after reaching that place. There were no bruises or cuts on his body, and that he was injured internally is not questioned.

Brady was forty-two years old, and was employed by the United Fruit Company as a private watchman. J. N. Russell was conductor and Chris Goodyear the motorman of the car which struck him.

Brady was knocked down by the car, falling to one side of the track, and not on it.

MR. UGLAND HURT.

Anders E. Ugland, vice consul of Sweden and Norway, was knocked down and injured by a car at Canal and Chartres streets early this morning. Mr. Ugland was carried into May's Drugstore and

"Whereas, the bill is palpably unjust, owners of marsh lands would be made to pay possibly two taxes on lands from which they derive no revenue.

"Whereas, the drainage of said marsh lands would be impeded by the rising of the waters of the Mermantau, by locks, dams and levees, especially since the Gueydan drainage district drains into the Mermantau river, as well as all marsh lands west of the Mermantau river.

"Whereas, the bill burdens every taxpayer, whether he be benefited or not, to a possible ten-mill tax, a land owner to two possible taxes a tenant to a possible 2 1-2 cents per bag of rice, besides taxing his mules and implements a possible ten-mill tax, and finally burdens a land owner who raises rice to three possible taxes, aggregating the enormous figures of 55.8 mills, based on a \$6 land assessment;

"Resolved, That we condemn our Representatives and Senators for not doing everything in their power to defeat this unjust law, and for not consulting with us on the subject, and that we pledge ourselves to use our utmost endeavors to kill said measure, that threatens our homes and liberty."
