## BIG FIRE AT MONTGOMERY.

**Watchmen Declare Torch Was Applied to Lumber Plant.**

MONTGOMERY, Ala., July 17.—Fire at 3 o'clock this morning completely destroyed the plant of the Alabama Rift Flooring Company, said to have the finest lumber plant in Middle Alabama. The loss is \$200,000, only partially covered by insurance.

It is firmly believed the fire was of incendiary origin, the night watchman claiming to have seen the torch applied. The plant has been completed and in operation less than a year. The property covered four acres, and consisted of a planing mill, an immense lumber shed, three large dry kilns, a dust house and a boiler house. There were 300,000 feet of dressed lumber in the sheds and 48,000 feet of rough lumber in each of the dry kilns.

Watchman Hall says he discovered a man in the extreme end of the lumber shed a few minutes before the fire broke out. He followed close on his heels and saw him run from one of the dry kilns. Almost immediately, he says, flames burst from the kiln. Flames burst forth from three different parts of the lumber shed. The statement of Hall is corroborated by the watchman for the Montgomery Lumber Company, whose plant is located just east of the burned property.

The Alabama Rift Flooring Company was owned by Pennsylvania capitalists. J. W. Hogarth of Scranton, Pa., is president of the company.
